Minnesota's Massive Gun Ban Bill

The Minnesota Senate passed SF4067 by ONE vote — 34-33.

Now the bill moves to the Minnesota House, where Democrats and Republicans are tied 67-67.

If anti-gun legislators gain even ONE vote, this bill could become law.

The Minnesota Gun Owners Caucus is leading the fight to stop SF4067 and defend the rights of Minnesota gun owners.

WHAT SF4067 DOES

BANS COMMONLY OWNED FIREARMS

- Bans many semi-automatic rifles, pistols, and shotguns
- Redefines all of these as "assault weapons"
- Generally, any semi-auto rifle with a detachable magazine is banned

MAGAZINE BAN

- Bans magazines over 17 rounds
- Restricts sales, transfers, and possession
- Criminal penalties for noncompliance

FIREARM REGISTRATION

- Requires state certification of grandfathered firearms
- Mandatory renewal every 3 years
- Government fees and paperwork
- Criminal penalties for violations

RESTRICTS HOMEMADE FIREARMS

- Limits personal firearm manufacturing (3/yr)
- Requires serialization through FFLs
- Restricts unfinished frames and receivers
- Targets 3D printing and CNC manufacturing

BANS SOME 3D PRINT FILES & CAD FILES

- Restricts digital firearm instructions
- Criminalizes some file sharing and distribution

EXPANDS RED FLAG CONFISCATION

- Expands confiscation authority
- Longer confiscation orders
- More due process concerns

GOVERNMENT EXEMPTIONS

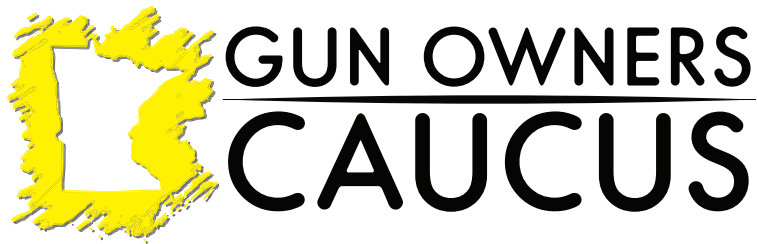
- Law enforcement exempted
- Government agencies exempted
- Restrictions apply to ordinary citizens

THE HOUSE CAN STILL STOP THIS BILL

The Minnesota House is tied 67-67.

If Republicans hold together, SF4067 can be defeated.
